| 1 | Road outside Station | Children | 1 3 | 3 | Warn to be alert for moving cars outside station | 2 |
| 2 | Fire or other emergency where evacuation required | Staff, volunteers, all visitors | 2 2 | 4 | Explain evacuation procedures and point out fire exits. | 2 |
| 3 | Call out / Shout | Staff, volunteers, all visitors | 2 2 | 4 | Explain what happens if a call out/shout occurs and what the group is expected to do if this happens | 2 |
| 4 | Illness/Accident during visit | Staff, volunteers, all visitors | 2 1 | 2 | Check supervising adults have their own procedures. Know location of first aid kit and any first aider | 1 |
| 5 | Irresponsible behaviour by individuals | Children | 2 2 | 4 | Ensure that supervising adults maintain a suitable level of discipline. Brief children in introduction. If there is a problem require supervising adult to remove child, in the extreme stop visit | 2 |

| 6 | Weather | All visitors | 1 1 | 2 | Ensure group has suitable clothing/ footwear for visit | 1 |

| 7 | Tripping, falling/slipping Uneven or wet surfaces | All visitors | 2 2 | 4 | Warn group to be careful, repeat warning throughout visit Check surfaces clear before visit | 2 |
| 8 | Injury from equipment Damage to clothing | All visitors | 2 2 | 4 | Warn group to be careful and not to touch equipment, repeat warning throughout visit Warn group not to touch or lean against equipment Check dangerous equipment is removed before visit | 2 |
| 9 | Child Protection | Staff, volunteers | 2 3 | 6 | Avoid being alone with any child. If kit is tried on avoid physical contact with child. Always ask for volunteers | 4 |
| 10 | Trying on kit | Children | 2 2 | 4 | Ensure careful supervision by adult if lifejacket is tried on warn not to touch inflation tag or flares. Ensure that only parent/guardian assists child with dressing up. NB – it is preferable to use display jackets where available, if operational lifejackets are used ask permission of the LOM and ensure only trained personnel remove any items and refit them correctly. Ensure child cannot fall against any equipment whilst trying on kit | 2 |
| 11 | Tractor, falling or tripping and injury from equipment | All visitors | 2 2 | 4 | Warn not to touch or lean on. Rope off bar to boat and warn not to climb across | 2 |
| 12 | Slipway launch | All visitors | 2 4 | 8 | Everyone instructed where to stand well away from slipway to view launch | 4 |
| 13 | Falling off Slipway | All visitors | 2 3 | 6 | Warn not to go onto slipway, put barrier across | 4 |
| 14 | ILB - Falling from boat and injury from equipment | Children and supervising adults | 2 3 | 6 | Instruct not to climb into boat and not to touch equipment. D class area roped off. Only taken into D class area once behaviour is assessed as good. Check electric cable to boat is above head height | 4 |

| 22 | Tractor, carriage and ancillary equipment | All visitors | 2 2 | 4 | Warn that surfaces may be slippery and coated anti corrosion spray and warn not to touch or climb across | 2 |

| 21 | Chemicals and Substances | All visitors | 2 4 | 8 | Substances and chemicals stored in locked containers/cupboards away from visitors | 4 |
| 20 | Visitors on ALB - Unaccompanied children | Children | 2 2 | 4 | All children to be accompanied by an adult before being allowed onto the boat. | 2 |
| 19 | Visitors on ALB - Cabin steps/open hatches | All visitors | 2 3 | 6 | Cabin door and hatches will be opened to view visitors to be warned to be aware of falling/tripping | 4 |
| 18 | Visitors on ALB | All visitors | 2 3 | 6 | All visitors to be accompanied by an RNLI representative before being allowed onto the boat. | 4 |
| 17 | Visitors on ALB – All equipment aboard ALB i.e. Knives and hammers buttons switches etc. | All visitors | 2 4 | 8 | Warn that under no circumstances should any equipment be touched or interfered with. | 4 |
| 16 | Visitors on ALB - Tripping hazards throughout, increased risk with numbers of people. | All visitors | 2 3 | 6 | A ratio of 10 students to one adult group leader and one RNLI representative at all times. Note increased danger of trip hazards (e.g. Quarter stop brackets and mooring bollards) | 4 |
| 15 | ALB – viewing from platform | All visitors | 2 3 | 6 | Boat viewed from platform maximum group size on platform 16. Locked barrier to boat. | 4 |
